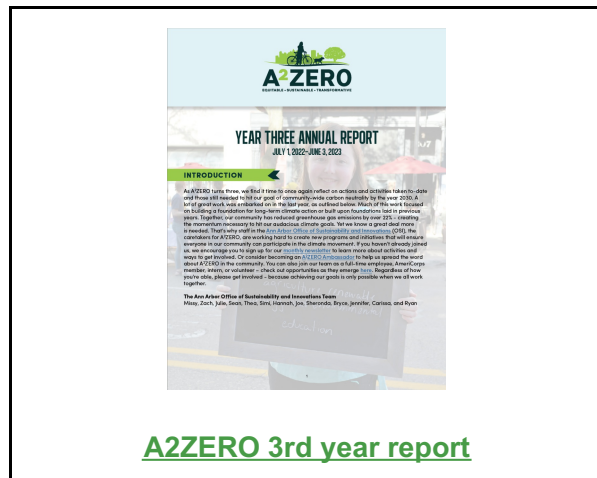
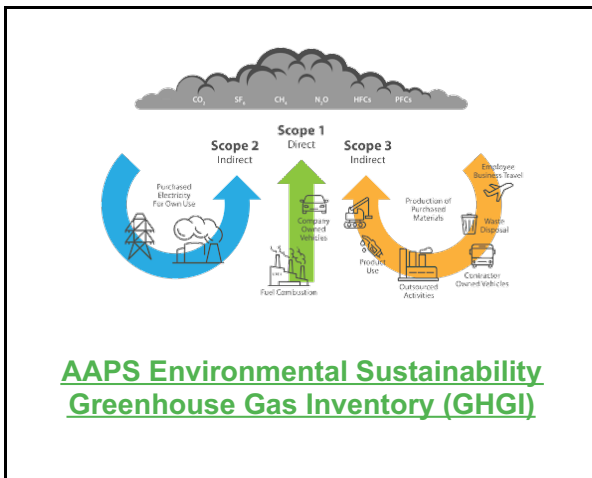
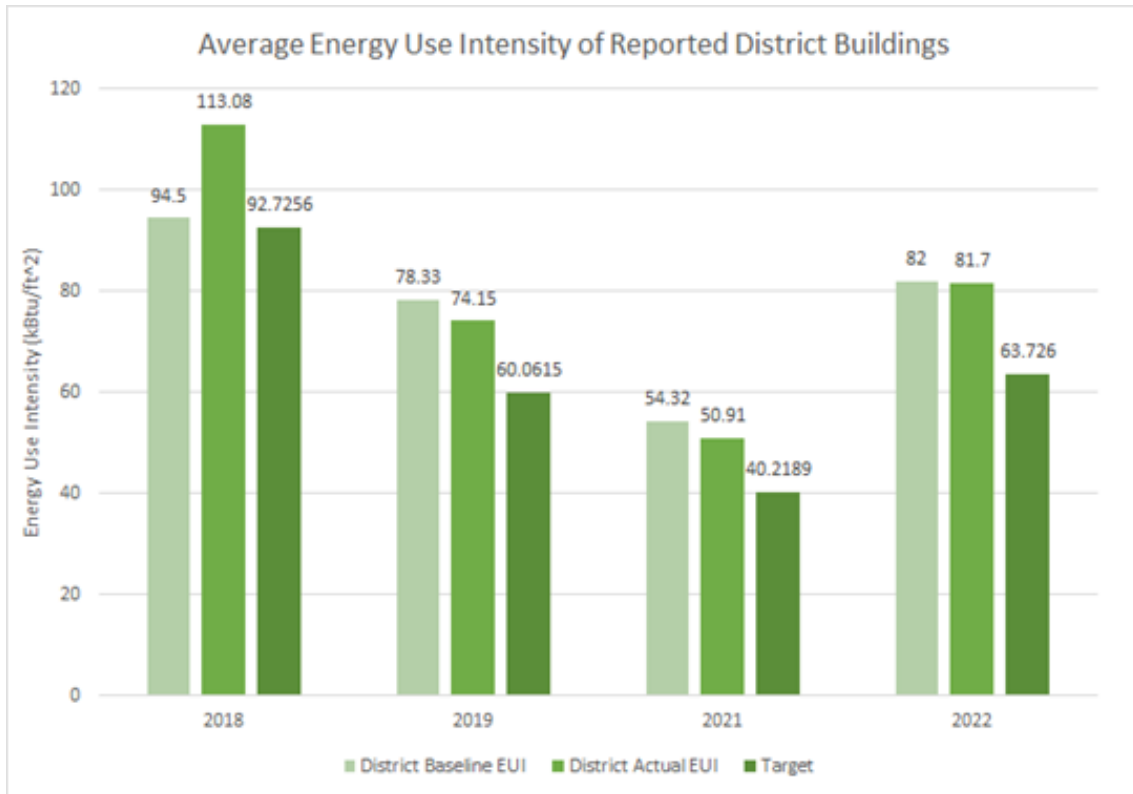


The diversity of our building uses:

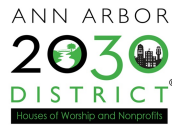
Count of Property Type - Self-Selected

Major IRA Announcement by US Treasury and IRS

Proposed Guidance on Elective Pay (Direct Pay) under the Inflation Reduction Act (IRA) has been issued by US Treasury and IRS. Elective Pay will help nonprofits, states, local governments, and other eligible entities access solar, storage, and wind tax credits.
