

City of Ann Arbor - Benchmarking Extention

For covered buildings or properties 100,000 square feet or greater:

- 2024 deadline: extended to September 1, 2024. Enforcement for buildings out-of-compliance will begin after September 1.
- Covered buildings or properties 100,000 square feet or greater must benchmark 2021, 2022 and 2023 calendar year data by September 1, 2024.

For covered buildings 20,000-99,999 square feet:

- 2024 deadline: The deadline after which enforcement will begin for these buildings is postponed from June 1, 2024 to June 1, 2025.
 - **-**Covered buildings or properties 50,000-99,999 square feet must benchmark 2022, 2023 and 2024 calendar year data buy June 1, 2025.
 - -Covered buildings or properties 20,000-49,999 square feet must benchmark 2023 and 2024 data by June 1, 2025.

The **EMPOWER Workplace Charging Project** is catalyzing workplace charging (WPC) adoption by connecting workplaces nationwide with local workplace charging coaches, reducing barriers through education, and providing access to a centralized library of helpful workplace-focused resources.



The Office of Sustainability and Innovations is pleased to announce the launch of the Residential Energy Rebates at osi.a2gov.org/rebates. This program is brought to you with funding from the Community Climate Action Millage passed by voters in 2022.

These rebates will help Ann Arbor residents make improvements to their homes and invest in cleaner transportation options to reduce carbon emissions, lower energy usage, and help move the City towards our A²ZERO goal of a just and equitable transition to community-wide carbon neutrality by 2030.

Reminder / ICYMI

ALERT - are you currently enrolled in DTE's **VOLUNTARY MIGreenPower program?**

By participating in MIGreenPower, you're reducing your personal carbon footprint while supporting the development of new wind and solar energy projects in our state.

As a MIGreenPower participant, you pay a subscription fee and receive a market-based credit for your enrollment, both of which are indicated on your monthly DTE Electric bill. Starting June 1, 2024, your net cost for MIGreenPower (subscription fee minus credit) increased from -0.34 cents to 2.5 cents per kilowatt hour.

Control your cost with MIGreenPower Fixed pricing

MIGreenPower Fixed pricing, which lets you decide how much you want to pay – as little as \$1 – for the program each month. The Fixed pricing program gives you all the benefits of MIGreenPower while enabling you to control your individual program cost.
